Important Remark regarding duty on liquor : For liquor, duty is assessed according to the percentage of pure alcohol present. Three different tax levels are applied on the value of the goods. The duty rates can refer to the Dutiable Commodities Ordinance. Duty is payable on the following types of liquor at the rates, expressed as a percentage of the value, indicated opposite each type of liquor: Liquor with an alcoholic strength of more than 30% by volume (measured at a temperature of 20°C) = 100% duty; Liquor, other than wine, with an alcoholic strength of not more than 30% by volume (at 20°C temp.) = 20% duty; Wine..... = 40% duty

Where there is no or insufficient information available from which the Commissioner of Customs and Excise (or any officer authorized by him for this purpose) is able to determine the value of any quantity of liquor of less than 12 litres, imported at any time in one consignment, he may assess the duty payable on such liquor the minimum rate of HK\$ 160 per litre.

These Duty levels are subject to change by Hong Kong Customs and Excise Department.
